1. The India has received financing from the Asian Development Bank (ADB) towards the cost of "Himachal Pradesh Skill Development Project". Part of this financing will be used for payments under the Contract Package named above. Bidding is open to Bidders from eligible source countries of the ADB.
2. The "Public Works Department, Government of Himachal Pradesh, represented by Chief Engineer, (Shimla Zone)", Shimla ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of the Center of Excellence at Waknaghat, in District Solan of Himachal Pradesh (SH:- Construction of Building Portion including Water Supply, Sanitary Installation, Electrical Installation, Site Development, Boundary Walls, Rain Water Harvesting System, Environment Management, Safety Measures, Indoor Transformer, HT and LT panels, Cabling, DG Set, external lighting, Central Air Conditioning with humidity control (Hot and Cold), CCTV & access control and other Miscellaneous items etc..) ("the Works").
3. National competitive bidding will be conducted in accordance with ADB's Single-stage: Two-envelope procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
  - a) Participation in at least one contract that has been successfully or substantially completed within the last *five years* and that is similar to the proposed works, where the value of the Bidder's participation exceeds INR 306.0 million;
  - b) Minimum average annual construction turnover of INR 815.0 million, calculated as total certified payments received for contracts in progress or completed, within the last *five (5)* years;
  - c) Has financial resources to meet its current contract commitments, plus INR 51.0 million requirements for the Subject Contract;
  - d) Participation as contractor in at least 1 contract within in the last five years, that has been successfully or are substantially completed, and that include pre-engineered material, where the value of the Bidder's participation exceeds INR 100.0 million;
  - e) Participation as contractor in at least 1 contract within in the last five years, that has been successfully or are substantially completed, and that include Design and Construction of building work, where the value of the Bidder's participation exceeds INR 200.0 million;

However for complete eligibility and qualification requirements, bid document should be referred.
