

The quotation for obtaining the tender form without EMD will not be accepted and the tender form can be had from this office against cash payment (Non refundable) up to 5.00 P.M. on 3.7.2021.

The earnest money in the shape of National Saving Certificate/ Time deposit accounts/Saving account in any of the Post Office and Banks of Himachal Pradesh duly pledged in favour of the Xen Mandi Division No.II must accompany with each tender. Conditional tender and the tender received without earnest money will summarily be rejected. The earnest money should be attached with quotation. The offer of the tender shall be kept open for 90 days. The Executive Engineer reserves the right to reject the tender without assigning any reason.


