



The concerned Department(s) and Sub Divisional level offices etc. are advised that whenever there is a need of service of any Advocate, they may engage the above Advocate(s) and settle reasonable terms and conditions of fee with them, whereafter, the proposal may be sent through their Administrative Department, for approval of Law Department. Further, where more than one Advocate is empanelled for the same Department, the cases will be distributed on rotation basis.

However, the terms and conditions of fee in respect of the Revenue case before the Revenue Officers/Revenue Courts relating to the various Government Departments will be ₹5000/- (Five Thousand) plus ₹500/- (Five hundred) miscellaneous expenses per case as notified by this Department notification No. LLE-E(9)-2/2018-Loose, Dated 2<sup>nd</sup> December, 2019 and 15<sup>th</sup> February, 2022.

The expression "Revenue Cases" shall include all matters/proceedings relating to encroachment cases, correction cases or any other case where interest of the State Government are required to be safeguarded in the Court of Law.


