ORDER

WHEREAS, Sh. Pawan Kumar, Superintendent Gr. II upon recommendations of DPC made in its meeting held on 07.06.2022 was promoted to the post of Superintendent Gr. I on 01.07.2022, but he preferred representations dated 28.12.2021 & 06.08.2024 for his promotion with retrospective effect from the date when his junior Sh. Nathu Ram was promoted to the post of Superintendent Gr. I on 19.06.2020;

WHEREAS, in view of his above representations, the relevant record was gone through and found that he was considered for promotion to the post of Supdt. Gr. I by the Departmental Promotion Committee (DPC) in its meetings held on 15.06.2020 & 11.06.2021 but owing to pendency of FIR No. 05/2012 dated 07.12.2012 registered u/s 420, 467, 468, 471, 120B of Indian Penal Code and Section 13(2) P.C. Act at Police Station SU & ACB Bilaspur against him, the recommendation made by the DPC in respect of said officer was placed in a sealed cover;

WHEREAS, the Hon'ble Court of Ld. Special Judge Bilaspur vide judgment dated 24.07.2021, in Str. (Corruption) case No. 1/1 of 2019 titled as State Vs Chandu Ram & others registered in above FIR, had discharged Sh. Pawan Kumar from the charges leveled against him, thus upon his such exoneration, sealed cover containing assessment of DPC(s) held on 15.06.2020 & 11.06.2021 with regard to his promotion to the post of Superintendent Gr. I should be considered to be opened as per provisions contained in para 16.32 (2) (iv) of CHAPTER 16 (PROMOTIONS AND SELECTION GRADE) of Hand Book on Personnel Matters Vol. I. which upon scrutiny, has been opened now;

AND WHEREAS, on perusal of recommendations placed in the sealed cover, it is found that the Departmental Promotion Committee has recommended the name of Sh. Pawan Kumar, Supdt. Gr. II for promotion to the post of Supdt. Gr. I on regular basis in the event of his exoneration in a Vigilance/Departmental case pending against him, with further recommendation to place him above the name of Sh. Narotam Singh (Sen. No. 146) in the panel drawn for promotion to the post of Supdt. Gr. I. Since, the promotion order of Sh. Narotam Singh to the post of Superintendent Gr. I was issued vide this department notification No. PBW-A-B(2)-7/2019, dated 13.07.2020, therefore, the promotion order of Sh. Pawan Kumar, to the post of Superintendent Gr. I on notional basis,

is required to be issued in continuation of said notification and he is to be placed at Sr. No.1 above Sh. Narotam Singh (Sr. No. 1). Record reveals that Sh. Nathu Ram (Sen. No. 157) was recommended to the post of Superintendent Gr. I prior to Sh. Pawan Kumar (Sen. No. 145) against the point of reserved Category; and

NOW THEREFORE, the Governor of Himachal Pradesh is pleased to order the promotion of Sh. Pawan Kumar (D.o.B. 10.01.1965) to the post of Supdt. Gr. I on regular basis w.e.f. 13.07.2020 on notional basis and he is to be placed at Sr. No.1 above Sh. Narotam Singh. Further, the name of Sh. Pawan Kumar, Superintendent Gr. I will appear at seniority No. 31A above Sh. Nathu Ram (Sen. No. 32) in the final seniority list of Superintendent Grade-I issued vide this department notification No. PBW-A-B(6)-2016 dated 09.06.2021.
