TERMS & CONDITIONS:-

1. The undersigned reserves the right to accept or reject any / all of the bids without assigning any reason.
2. The undersigned reserves the right to reject the offer received during open auction at any time without assigning any reason, if required.
3. The highest /successful bidder shall need to lift the auctioned Vehicles/Machines within 07 days from the date of auction /date of receipt of 100 % payment, which ever is later, else ground rent @1% per week shall be charged from the highest /successful bidder for 1st month & 5% onwards, per week.
4. The Vehicles / Machines being auctioned are available for inspection on all working days during office hours up to 26.08.2025, as detailed above.
5. Self attested photocopies of PAN, AADHAAR and GST registration No. are required to be provided/submitted along with the application while seeking tender forms.
6. The GST as applicable shall have to be deposited by the highest / successful bidder with the authority under Reverse Charge Mechanism (RCM) as per the provision of extant GST Rules, prior to physical lifting of Vehicles/Machines.
7. The Earnest Money of successful bidder shall be retained till lifting of vehicle/machines and earnest money of other unsuccessful bidders shall be refunded after opening of the bid.
8. The highest / successful bidder shall have to deposit at least 25% of the bid amount on the spot on the same day and remaining 75% amount within next 7 days after the process of tender/auction, through DD in favour of Executive Engineer, Mechanical Division, HP.P.W.D Dharamshala. If the highest bidder fails to deposit the whole amount within prescribed period the 25 % of the accepted bid as well as EMD amount shall automatically stand forfeited. If the highest bidder fails to deposit the 25% of the bid amount on the same day then whole EMD amount shall be forfeited.
9. In case of open auction, an amount to the tune of Rs. 1000/- shall have to be deposited in cash as security for participation, which shall be refunded back to the unsuccessful participants on the spot after auction process is completed.
