Whereas, the matter regarding consideration of Degree obtained by Sh.Dhawal Kumar & Sh. Hemant Kumar, Junior Engineer(Mech.) to consider the same at the time of appointment or during service as Junior Engineer on contract basis was under consideration at Govt. level.

And whereas, the Govt. of HP vide letter No.PWD-A-B0 (8)/12/2024 dated 29.03.25 has conveyed the approval of Govt. to grant ex-post facto permission in favour of Sh. Hemant Kumar, JE(Mech.) to pursue/ complete their B.Tech. degree course during the year 2017 who had appeared in final examination of last semester.

And whereas, the incumbents who were similar situated to Sh.Dhawal Kumar who had appeared in examination prior to appointment as Junior Engineer, but final result was declared after appointment were considered as obtained degree during service, hence, it is felt necessary to consider the same (already incorporated in final seniority list dated 24.12.24 as it stood on 31.10.24 & 2.05.2025 as it stood on 31.03.25) as obtained during service in respect of Sh. Dhawal Kumar, Sen.No.22 and Sen.No.38 Sh. Hemant Kumar in final seniority list dated 4.4.23 as it stood on 31.12.22.

Now, in view of decision, in the final seniority list of Junior Engineer(Mech.) as it stood on 31.12.2022, circulated vide letter No.211-20 dated 04.04.23 the Technical qualification of Sh.Dhawal Kumar as i.e.B.Tech. in Mech.Eng. as shown in Col.No.5 (at the time of appointment) is hereby deleted and added in Col.No.6 Technical qualification During Service. Further, the technical qualification so obtained by Sh.Hemant Kumar, Junior Engineer appearing at Sen.No.38 during service is hereby included in the final seniority list in Col.No.6, Technical Qualification During Service as “ B.Tech.in Mech. Eng. during May,2017”.

However, the Technical Qualification during service as entered in Col.No.6 shall be subject to final outcome of Court cases pending before Hon'ble High Court in similar matters.

The above Corrigendum/addendum may be circulated amongst the Junior Engineers working in the department for inviting objections, if any, and same may be brought to the notice of this office with 10 days or the seniority will be treated as final.
