

The issue of coverage of contract workers and construction workers under the EPF & MP Act, 1952 has been flagged as an area of top most concern and priority by the Government of India. In this connection, I would like to invite your attention towards deposit of Provident Fund by contractors of major Principal employers. It is often observed that the contractors claim huge amount towards EPF of contract workers from the Principal Employer but either do not deposit it at all or deposit it partly, thus depriving these workers of Provident Fund, Pension and Insurance benefits. It is noticed that many employees are engaged on Contract/Outsourced basis by the (i) State Public Works/Irrigation department (ii) Electricity-generation, transmission, distribution companies (iii) Various other departments of State Govt.

2. In this regard, your kind attention is drawn to Paragraph 30(3) of the Employees' Provident Fund Scheme, 1952 which provides that it shall be the responsibility of the principal employer to pay the contributions payable by him in respect of the employees employed by or through a contractor. To facilitate this, a provision is available on the official website of EPFO www.epfindia.gov.in on the "establishment search option" to verify as to whether the agencies and contractors having Provident Fund Code numbers are regularly depositing Provident Fund contributions every month in respect of all the employees deployed by them. The above facility can be utilized to check the compliance position of the agencies and contractors to the provisions of the Act and the Schemes framed thereunder in respect of the contracts awarded by various Departments.

3. Further, with the view to make the system more robust, transparent and to reduce the cost of compliance to the employer, EPFO has launched a facility for the principal employers to upload at the EPFO website, the details of contract employers of each contract awarded by them. The entire information can be viewed and updated by principal employer at any time. The Regional and Sub-Regional Office will also take steps to secure compliance of employees engaged by the contractor towards Employees Provident Fund. The representative of Departments can contact the concerned Regional PF Commissioner of the Regional/Sub-Regional Office to get any assistance in the matter.

4. I request you to issue suitable directions to the different departments of the State, including Public Sector Undertakings to upload the details of all contract employers of each contract to facilitate compliance under EPF & MP Act, 1952.
