Subject: Guidelines for timely settlement of Pension and GPF Cases to minimize Court Cases.

Sir/Madam,

 This is with reference to the letter received from the Principal Accountant General (A&E), Himachal Pradesh, regarding concerns raised by the Office of the Comptroller & Auditor General of India about the large number of court cases involving government departments and field offices. It has been observed that most of these cases pertain to entitlement functions, specifically General Provident Fund (GPF) and pension-related matters. The primary reasons for these litigations are errors and delays in the settlement of entitlement cases.

O. D. E.
 The following are the key areas of concern which needs immediate corrective action by the departments/offices:

A. Timely Submission of Pension Cases:

- o As per Rule 61 of the CCS (Pension) Rules, 1972, pension case papers should be forwarded to the Accounts Officer at least six months before the superannuation date of the concerned government servant.
- o In cases other than retirement on superannuation, pension documents must be submitted not later than three months after the submission of Form 5.

B. Due Diligence at the level of Pension Sanctioning Authorities:

- o The Pension Sanctioning Authorities must strictly adhere to the instructions issued by the Government of Himachal Pradesh while processing pension cases.
- o Special attention is required on the following aspects:
 - Pay fixation anomalies post-implementation of the 6th Pay Commission.
 - Transition from the National Pension System (NPS) to the Old Pension Scheme (OPS).
 - Counting of contract service for pensionary benefits.
 - Implementation of judgments passed by Hon'ble Courts.

- Government directions on pension matters issued from time to time.

C. Areas of Concern in respect of GPF Cases:

- GPF final payment cases should be sent to the Principal Accountant General (A&E) before the retirement of the subscriber as per GPF (CS) Rules, 1960.
- Retention cases should be forwarded within six months after the retirement of the subscriber, as per the Finance Department Notification dated 28 August 2007.
- GPF subscription should be discontinued three months before the superannuation of the government servant, in accordance with Rule 7 (GID-1) of the GPF (CS) Rules, 1960.

Therefore, with the objective to ensure that pensioners and GPF subscribers are not subjected to unnecessary inconvenience and also to minimize the litigations, timely processing of entitlement claims, the corrective measures as elaborated above may strictly be followed by all the departments and their subordinate offices.

Non-adherence of these instructions effectively and efficiently by the concerned officer/official will be viewed seriously by the Government.
