
I am directed to refer to your letter No. PW/CTR/32-20/General Instructions/25-12804 dated 17.10.2025 on the subject cited above and to convey the approval of the Government to limit the works in hand to be awarded to Contractors i.e. Class A, B & C, in supersession of instructions issued vide this Department letter No. PBW(B)F(1)/2023 dated 04.10.2023, as under:

Class A	Neither should have more than 2 works of awarded amount more than 20.00 Crore each nor should have sum of all awarded works more than 100.00 Crore.
Class B	Neither should have more than 2 works of awarded amount more than 5.00 Crore each nor should have sum of all awarded works more than 20.00 Crore.
Class C	Neither should have more than 2 works of awarded amount more than 2.00 Crore each nor should have sum of all awarded works more than 8.00 Crore.

The aforesaid condition will apply to all the contractor/firm /company of all wings i.e. Civil/Electrical/Mechanical in the State for works under CRIF, NABARD and State works only. These instructions also apply to all contractor/firm having work awarded on his name/joint venture/as sub-contractor, in any Government Department.

It is, therefore, requested to circulate these instructions to all concerned for strict compliance with immediate effect and upload the same on official web portal of the department. Action taken report in this regard may be sent to this department immediately.
