OFFICE ORDER

Whereas, Sh. Vijay Thakur S/O Shyam Lal R/O Village & P.O. Kui, Tehsil, Rohru, Distt., Shimla, H.P. has been enlisted as class "A" Contractor with HP PWD, vide Office Order No. Pw/-CTR-32-2 (6)/2008-8063-8161 dated 13/06/2008, on the basis of the work done certificates issued by the Airport Authority of India, Air Port Project Division, Amritsar.

Whereas, a complaint against Sh. Vijay Thakur, Contractor has been received in this office through the Additional Chief Secretary (PW) to the Govt. of H.P., vide letter No. PBW(B) (B) (F) 14(6) 1/2010-II dated 30/10/2014 alleging that work done certificates submitted by Sh. Vijay Thakur with the application during the enlistment are fake.

And whereas, the qua certificates were got verified from quarter concerned vide letter No. PW-CTR-32-2-Misc/2014-18892 dated 09/12/2014 and even file No. 1792 dated 27/04/2015. In reply of these letters the Airport Authority vide letter dated 05/05/2015, straight way refused that neither these documents have been issued from their office nor such type of office is existing at Amritsar.

And whereas, show cause notice has been served upon Sh. Vijay Thakur, Contractor vide this office letter No. PW/CTR-32-2(RTI)/2014-22649 dated 21/10/2015, as the work done certificates submitted by him at the time of enlistment are forged as intimated by the issuing authority.

And whereas, the reply submitted by Sh. Vijay Thakur, Contractor in response to the show cause notice supra has been found contradictory according to all supporting/ inquired documents.

And whereas, the complete case was referred to the Govt. of H.P. vide this office letter No. PW/CTR/32-2(Vig.enq/2015-7691 dated 01/08/2015 to seek necessary opinion and to take further course of action.


And whereas, the Additional Chief Secretary (PW) to the Govt., of H.P. vide his letter No. PBW(B)-F-14-(6)1/2010 dated 28th August, 2015 has opined that the matter has been examined at the Govt. level and due to various contradictory communication in the case advised to blacklist the said Contractor.

And whereas, in exercise of the powers delegated to the undersigned vide Govt., notification No. PBW(B)22-1/2002 dated 26/05/2015, under rule 23.1,d,e,f,e & Sh.Vijay Thakur, S/O Shyam Lal, R/O Village & P.O Kui, Tehsil, Rohru, Distt., Shimla H.P. Class "A" Contractor, enlisted vide this office order No. PW/-CTR-32-2 (6)/2008-8063-8161 dated 13/06/2007 is hereby Blacklisted/removed from the approved list of Govt., Contractor and debarred from participating in the tender process of HP PWD, CPWD, State/Central Govt., departments & undertakings, boards and corporations etc with immediate effect.
