**Subject:** Deposit of GIS subscription of HP Government employees working in Board/Corporations/SABs.

As you might be aware that presently HP Government employees working in Board/Corporation/SAB's etc. on deputation/ secondment deposit their GIS subscription either by sending cash or cheque to their parent department.

It is intimated, that now the HOA 8011-00-107-01/02 (Insurance/ Saving Fund) had been enabled in the e-challan (HimKosh) for online deposit of the GIS subscription. The deduction of GIS of employee on deputation/secondment can now be deposited using online banking/NEFT/ Debit card or UPI in favour of the DDO of the parent department. Further, the reconciliation of GIS subscription maybe carried out on half yearly basis by the parent department on the Cyber Treasury/eKosh so as to avoid discrepancies in subscriber contribution.

It is therefore, requested to direct the DDOs of your department to adhere to the above procedure.
