

NOTIFICATION

In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor, Himachal Pradesh is pleased to make the following rules further to amend rule 56 of the Fundamental Rules (in its application to the State of Himachal Pradesh), namely:-

Short title and  
commencement.

1. (1) These Rules may be called the Fundamental (in its application to the State of Himachal Pradesh) Amendment Rules, 2015.

(2) These rules shall come into force with immediate effect.

Amendment of rule-56.

2. In rule-56 of the Fundamental Rules (in its application to the State of Himachal Pradesh), clause(dd) shall be omitted.

Repeal

3. (1) The Fundamental (in its application to the State of Himachal Pradesh) Amendment Rules, 2014 notified vide Notification No. Fin(C)A(3)-2/2013 dated 28-05-2014 and published in Rajpatra Himachal Pradesh on 29-05-2014 are hereby repealed.

(2) All Government Servants who have been granted extensions under the rules so repealed under sub rule(1) shall stand retired on the afternoon of 31<sup>st</sup> of March, 2015.

(3) All extensions applied for by any Government Servant or approved by any authority at any level under the rules so repealed under sub rule(1) shall be of no effect and such Government Servants shall retire on attaining the age of superannuation i.e. 58 years.

Subject:- Regarding extension in service under rule 56(d) of the  
Fundamental Rules.

Sir,

I am directed to invite a reference to this Department's  
Notification No. Fin.-C-A(3)-2/2013 dated 24<sup>th</sup> March, 2015 vide which the  
extensions in service granted under rule 56(dd) of Fundamental Rules, notified  
vide notification of even number dated 28<sup>th</sup> May, 2014, have been withdrawn  
and as a sequel thereto all Government servants who have been granted  
extensions beyond the age of superannuation shall stand retired on after noon  
of 31<sup>st</sup> March, 2015.

It has been observed that the above decision of the  
Government has caused hardship to certain Government servants who have  
been granted extension alongwith their seniors and could not get the benefit  
of promotion for the reason that both of them are now to retire on 31<sup>st</sup> March,  
2015.

In order to mitigate this hardship it has been decided by  
the Government in the public interest, that those Government servants who  
have been granted extension in service and could not get promotion due to  
extension granted to their seniors and are retiring on 31<sup>st</sup> March, 2015  
alongwith their seniors against whom they were to be considered for

for promotion, may be granted extension in service upto 16<sup>th</sup> April, 2015, as a special case, under rule 56(d) of the Fundamental Rules. This extension in service will also be applicable to the Government servants who are to superannuate on 31<sup>st</sup> March, 2015 and have been deprived of the benefit of promotion due to extension in service granted to their seniors.

All the Appointing Authorities are delegated the powers to accord extension till 16<sup>th</sup> April, 2015 and to decide such cases as a one time measure and will ensure that the promotion cases are considered by the DPCs and decided before 16<sup>th</sup> April, 2015.
