**ORDER**

Whereas Sh.Mast Ram Rana, Executive Engineer, HPPWD Division Bangana had filed an OA bearing No.280/2016 against his transfer as EE (D), HPPWD Circle, Hamirpur in the Hon'ble HP Administrative Tribunal.

Whereas the Hon'ble Tribunal has decided the said OA vide its order dated 19.4.2016 and has observed/directed as under:-

"In the fact and circumstances and interest of justice, the original application is disposed of with the stipulation that subject to the applicant making a detailed representation, supported by documents alongwith certified copy of this order, highlighting the above aspects and with a request for cancellation of the transfer in the first instance or suitable adjustment against an existing/likely vacancy out of at least two- three such vacancies to be indicated in the representation to meet the requirement under the transfer policy, to respondent No.1, through the Additional Chief Secretary (PW) to the Govt. of Himachal Pradesh, within a week from today, who shall consider and decide the same in accordance with law, sympathetically, and transfer policy framed by the State Government, by 15<sup>th</sup> May,2016, after affording an opportunity of being heard to the applicant as well as private respondent No.1, if so desired.

Whereas in pursuant to the above directions of the Hon'ble Tribunal, no representation was received from the said Sh.Mast Ram Rana, Executive Engineer, Bangana till 15.5.2016. However, before deciding this matter, it was decided to offer him an opportunity of personal hearing on 8.7.2016 by the undersigned in his office chamber. He was informed of this decision vide letter of even number dated 28.6.2016.

Whereas the said Sh.Mast Ram Rana attended the personal hearing on 28.6.2016 in the office chamber of the undersigned. He has made submissions for cancellation of his transfer but he could not provide any justification for his

continuation as Executive Engineer, Bangana Division and also miserably failed to explain as to why he could not join as EE (D) Hamirpur, whereas a class-I officer should be ready to work anywhere in the State. Besides, he could not provide any justification for having not opposed his short tenure while he was transferred from Baijnath Division to Bangana Division, for which he himself managed several U.O. notes.

And whereas there were complaints from the public regarding official working of the said Sh.Mast Ram Rana which matter was discussed with the Chief Engineer, Hamirpur, who has brought to the notice of the undersigned that the said Sh.Mast Ram Rana has limited capacity to perform the duties of a functional division where works are to be completed in a time bound manner and require constant follow up with other agencies.


Now, therefore, keeping in view the above mentioned facts and circumstances of the case, Sh.Mast Ram Rana, EE, Bangana Division cannot be retained at Bangana Division. Since, the post of EE (D) Hamirpur Circle against which has been transferred stand filled up, his posting order shall be issued separately.
