Whereas, Sh.Ravi Dutt Sharma, Assistant Engineer, Sub-Division Habban, Distt. Sirmour was served upon a chargesheet vide memorandum of even number dated 6.9.2014.

Whereas, vide the said memorandum dated 6.9.2014, he was directed to submit written statement in his defence within 10 days of the receipt of memorandum. He was also asked to state whether he desires to be heard in person or not.

Whereas, he submitted his written statements of defence vide his representation dated 24.9.2014, which has been examined. And whereas after careful consideration of the facts and circumstances of the case, it has been found that explanation of the said officer is cogent. Therefore, it has been decided that no further investigation is required in this case and the departmental proceedings initiated against him should be dropped.

Now, therefore, the Governor, Himachal Pradesh is pleased to order for dropping of chargesheet issued to Sh.Ravi Dutt Sharma, AE vide memorandum of even number dated 6.9.2014 and close the matter.

ORDER

Whereas, the representation dated 7.5.2015 of Sh.Rajinder Paul, Supdt.Gr.I (retd) has been received from the Engineer-in-Chief vide his letter bearing No.PWE-79-1-Supdt.Gr.I/ES-1-1611-12 dated 12.5.2015 vide which he has sought promotion to the post of Registrar after his promotion to the post of Supdt. Gr.I vide notification dated 5.11.2014 w.e.f. 30.5.1997 and his consequent seniority position at seniority No.37d in the seniority list of Supdt.Gr.I issued on 6.11.1999.

Whereas, it has been found that on account of assigning him the date of promotion to the post of Supdt.Gr.I w.e.f. 30.5.1997, his case is required to be considered for his promotion to the post of Registrar for which he has requested vide his representation dated 7.5.2015.

Whereas, for the promotion to the post of Registrar, the condition of three years of service, and passing of departmental examination were essential at that relevant time. He completed three years of service on 30.5.2000 on which date, he crossed the age of 55 years, hence, the condition of passing departmental examination may be relaxed for him. Therefore, he was eligible for promotion to the post of Registrar against the vacancies available w.e.f. 1.6.2000 till his retirement on 31.7.2002 and falls in the zone of consideration.

Whereas a review DPC for promotion of Supdt.Gr.I to the post of Registrar was convened on 2.12.2005. In the year 2000, one post of Registrar was vacant and one more post was available on 1.1.2001. Therefore, till 31.12.2002, only two posts of Registrar were available with the Department and thereafter next vacancy was available in the year 2004. The post of the year 2000 was filled up by promotion of Sh.Ashok Kumar Saini in compliance with the orders of Hon'ble Tribunal in OA No.227/88- Ashok Kumar Saini Vs State. Sh.Rumel Singh was promoted to the post of Registrar against the vacancy for the year 2001 and Sh.Shish Ram Chauhan was promoted against the vacancy available in the year 2004.

Whereas, Sh.Rajinder Paul has been assigned seniority No.37d in the seniority list issued on 6.11.1999 in which Sh.Rumel Singh is at Sr.No.7 and Sh.Ashok

Kumar Saini is placed at Sr.No.2. Therefore, none of the juniors of Sh.Rajinder Paul got promotion to the post of Registrar prior to his retirement on 31.7.2002.

Whereas, the post of Registrar is a selection post which is filled up on merit-cum-seniority basis and name of Sh.Rajinder Paul falls in the zone of consideration in the review DPC held on 2.12.2005 in which his junior Sh.Shish Ram Chauhan has been considered for promotion.

Whereas it has also been found that Sh.Ashok Kumar Saini (seniority No.2), Sh.Rumel Singh (Seniority No.7) and Sh.Zalam Singh (seniority No.31) were senior to Sh.Rajinder Paul, therefore, against the 1 vacancy of the year 2000, Sh.Rajinder Paul does not fall in the zone of consideration as three Supdt.Gr.I senior to him were eligible for promotion at that time.

And whereas the recommended candidate Sh.Rumel Singh (who is senior to Sh.Rajinder Paul) against the vacancy of the year 2001 had already been promoted to the post of Supdt.Gr.I in the year 1991 but Sh.Rajinder Paul had been promoted in the year 1997. There is difference of more than 6 years in their entry to the Supdt.Gr.I cadre, therefore, Sh.Rajinder Paul who is junior to the Sh.Rumel Singh will not supersede Sh.Rumel Singh as per provision contained in the Department of Personnel notification bearing No.Per(AP-II)-A(1)-1/80 dated 3/4 November,1981, supersession on the ACR assessment was only permissible when difference of length of service in the feeder grade between the two officers is not more than two years. As such, his request for promotion to the post of Registrar is not justified.

Now, therefore, keeping in view the above facts and circumstances of the case and material on record, the undersigned comes to the conclusion that Sh.Rajinder Paul's request for his promotion to the post of Registrar has no merit, hence, rejected.
