**Whereas**, Sh.Satish Kumar Chaudhary, Junior Engineer (Civil), HP,PWD Sub-Division, Rehan, Distt. Kangra has been promoted to the post of Assistant Engineer (Civil) vide this department notification of even number dated 15<sup>th</sup> June, 2015 and posted in HP,PWD Sub-Division Fatehpur.
