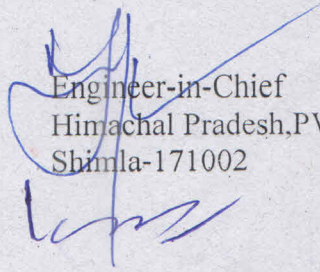
“OFFICE ORDER”
