Before accepting the joining reports of above promotees their original educational ITI certificates may be verified by the concerned office. In case, any one of the promotee does not fulfil the requisite qualification, his promotion orders may not be implemented and the case is required to be referred to this office.

All the above officials may be relieved immediately failing which it will be administrative lapse and action will be taken against the controlling officer.

In the event of their not joining the post within stipulated period i.e. with in 15 days, offer of promotion shall be deemed automatically withdrawn without notice and opportunity to next official in the line shall be promoted.

If any of the promotee proceeds on leave to avoid his joining in his new place of posting within stipulated period, disciplinary action will be initiated against the defaulter.

If an official forgoes his promotion then he will be considered for promotion after one year or whenever the post is available, whichever is later.

In the case, any error in the present place of posting of promotees occurs/or any other type of error regarding promotion, the same may be got rectified in consultation with this office.


